Senate Bill 1243, 84th Legislature, Regular Session, 2015 created the Prescription Drug Donation Pilot Program, codified in Texas Health and Safety Code, Chapter 431, Subchapter O. The pilot program is intended to allow certain unused prescription medications approved by the U.S. Food and Drug Administration to be donated to the Texas Department of State Health Services (DSHS) for distribution to charitable medical clinics, physicians caring for indigent or Medicaid-eligible patients, and penal institutions. By statute, DSHS is required to report to the Legislature the results of the pilot program no later than January 1 of each odd-numbered year.

As no funds were appropriated, DSHS was unable to implement the pilot program. As such, a report for 2021 has not been drafted. However, should adequate resources be made available, DSHS would be well-positioned to implement a drug donation program in Texas due to in-depth research conducted on other state drug donation programs in 2017.
