Agenda Item 1. Call to order, roll call, and welcoming remarks

Titilope Fasipe, M.D., Ph.D., Chair, called the Sickle Cell Task Force (SCTF) meeting to order at 1:11 p.m.

Dr. Fasipe provided welcoming remarks and turned the floor over to Jacqueline Thompson, Facilitator, Advisory Committee Coordination Office, Texas Health and Human Services Commission (HHSC).

Ms. Thompson read the logistical announcements and stated the meeting was being conducted in compliance with the Texas Open Meetings Act. Ms. Thompson conducted the member roll call and announced the presence of quorum.

Dr. Fasipe thanked members and Texas Department of State Health Services (DSHS) staff for their work. Dr. Fasipe then asked for a moment to reflect on those lost due to sickle cell and for whom they continue to fight.

Dr. Fasipe introduced Ms. Lori Gabbert Charney, Director, Maternal and Child Health Section, DSHS to provide NBS Unit program updates.

Agenda Item 6. SCTF Bylaws Amendment review

Dr. Fasipe reminded members they discussed the bylaws and proposed updates in their past few meetings. Dr. Fasipe reviewed the previous bylaws discussions with members and called for proposed amendments.

Agenda Item 7. Sickle cell emergency care

Dr. Fasipe introduced Jamie Barner, Ph.D., F.A.A.C.P., F.A.Ph.A., Professor and Division Head, Klinck Centennial Professor, Co-Director, Texas Center for Health Outcomes Research and Education, The University of Texas at Austin, College of Pharmacy, Health Outcomes Division, to present on sickle cell emergency care. Dr.

Barner referenced the PowerPoint and handout, *Patient Experience and Factors Influencing Willingness to Utilize the Emergency Department Among Individuals Living With Sickle Cell Disease: Mixed Methods Study*.

Presentation highlights included:

- Study background;
- Theory of planned behavior conceptual model;
- Methodology and approach;
- Qualitative and quantitative data analyses;
- Focus group results;
- Survey results;
- Summary of study findings; and
- Study limitations.

Member discussion:

- Study reflects what patients tell their doctors on a regular basis;
- Lack of objective research on patient experience causes frustration for patients and doctors;
- Once published, study will serve as a tool for the sickle cell community;
- Collaboration with Linda Wade;
- Linking study with Centers for Disease Control and Prevention (CDC) sickle cell work;
- Study publishing and presentation history; and
- Identifying conferences for a future presentation.

Agenda Item 8. House Bill 1488 presentation

Dr. Fasipe introduced Ms. Emily Stauffer Rocha, M.B,A., M.S.N., R.N., N.E.-B.C., C.H.C.Q.M, Director of Clinical Innovation, Office of the Medical Director, Medicaid & CHIP Services, HHSC, to provide an update on work to achieve Texas 88th Legislature, Regular Session, 2023, House Bill 1488 goals. Ms. Rocha referenced the handout, *Provider Education Resources*.

Presentation highlights included:

HHSC, DSHS, and Medicaid Contract Subcommittee collaboration;

- Medicaid Contracts Subcommittee worked on a draft document to meet a House Bill 1488 ask to recommend and promote existing resources or facilitate the development of provider education resources.
- Medicaid Contracts Subcommittee will also draft a document to meet a House Bill 1488 ask related to school resources.
- The Medicaid Contracts Subcommittee will share the provider education and school resource draft documents with the SCTF to review and include in the 2024 SCTF annual report.
